- 1) FOR 1-25 SPACES, PROVIDE ONE VAN ACCESSIBLE SPACE (10'X20'), PLUS ONE VAN ACCESS AISLE (5'X20')

STANDARD PARKING PROVIDED

- 1) EIGHT STANDARD 9'X19' STALLS
- 2) FOUR 9'X20' STALLS

ADA PARKING PROVIDED

- 1) ONE VAN ACCESSIBLE 10'X20' STALL
- 2) ONE VAN ACCESS AISLE (5'X20')

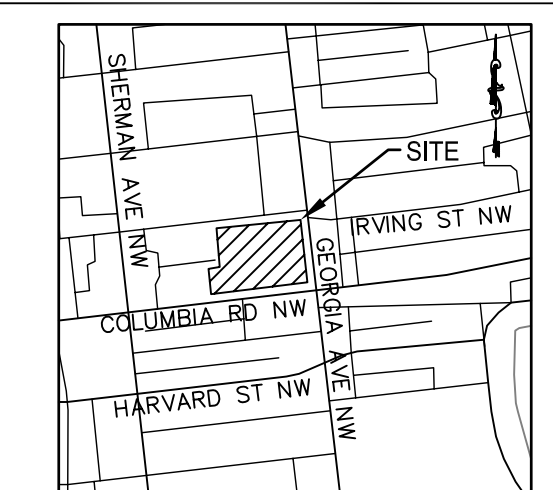
