RE: Confirming Official Data, D.C. Pre-K Access is Universal

The Office of the State Superintendent of Education (OSSE) is committed to improving the universal quality, access, capacity, service, and early learning for every child of pre-K age in the District of Columbia, every single day and from cradle to career.

And regardless of income, if you are a parent of a District of Columbia child of pre-k age and wish to enroll them in a pre-k program, a pre-k slot is universally available in the District of Columbia for you.

As cited under <u>District legislation</u> introduced by then-chairman Vincent Gray and completed under his Mayoral Administration, 'universal pre-k' is described as the availability of pre-k program slots for all children of pre-k age whose parents chose to enroll them. Universal Pre-K was the mandate given and Universal Pre-K is the goal accomplished, years ahead of schedule and in full compliance.

However, <u>recent reports have disputed this claim</u>, so while OSSE applauds media efforts to hold our agency accountable and investigate pre-k capacity and enrollment throughout the District, we must also insist the data on which we are measured is timely, accurate and factual.


As such, and for the sake of clarification and transparency, OSSE has published year-by-year District pre-k enrollment data spanning from 2008-2009 – the year pre-k legislation

was introduced - to 2011-2012.

OSSE is proud to announce that <u>from 2008 to 2012</u>, <u>the District of Columbia has</u>

<u>experienced a 35% increase in pre-k enrollment and to date</u>, 89% of <u>District 3 and 4-year-olds participate in pre-k programs citywide</u>. Results are based on annual enrollment audit summaries and annual <u>OSSE ChildTrends Reports</u>, and compared against annual <u>U.S.</u>

Census State Characteristics.
