Within my SMD, the buses travel on the main thoroughfare where on-street parking does not exist (Pennsylvania Ave, Alabama Ave, and Naylor Road). I would like for WMATA to provide additional buses for the routes that travel on these roads. I also would like to see more slow streets on these roads ways. This would make walking and biking on the streets safe. As it stands now, motorists travel in excess of 60 miles per hour on these streets.

- 3) **During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?**

Moving forward, I would like to see a hybrid model for ANC meetings. This would allow for greater community participation from the community stakeholders. It would also allow for diverse presenters and presentations from a variety of subjects to improve the quality of life for the Community. I have found the virtual setting to be a plus for the community as it has given more access to the meeting for many community members. It has also given community members the opportunity to learn new skills, specifically computer skills to navigate the world.

I believe the ANC has the opportunity to be a part of the planning conversation so that action is not done to us but with us. I believe my neighborhood has its fair share of affordable housing. I would like to see the District invest in maintaining the affordable housing that exists.

I would advocate support from the District and the Federal government to ensure these businesses have the funds to purchase the needed personal protection items so that their businesses can operate. I would like to see other District agencies to enforce the provisions of the public health emergency. We are not going to be able to police our way out of everything. There are other agencies that have enforcement responsibility.

One of the biggest issues in my neighborhood is speeding and the lack of enforcement of DC traffic laws. ANC 7B is home to six major traffic thoroughfare where hundreds of cars travel daily. Most of these cars are commuters from Maryland who speed through the street with no regard for the people who live in the Community. This also leads to the lack of enforcement of traffic laws where these cars use our neighborhood streets as short-cuts traveling to and from work during rush hour times. My position is that the District should do what it can to mitigate this problem. DDOT should quickly perform traffic assessments and make changes so that the Community is safe by adding speed limit indicators and cameras. Also, MPD is needed to simply write tickets when drivers violate the law.

Fortunately, that is not an issue in our neighborhood. However, if it was to become an issue, I would survey my neighbors and neighborhood groups to determine their needs and any objections to the removal of on-street parking. I would work collaboratively with neighbors to find a solution to improve service and enhance pedestrian safety. I would investigate viable and successful solutions done in other places and work with my neighbors to create the best plan for our neighborhood.

I think it has been a plus and minus. For those who do not have reliable internet service, it has been a minus. Yet, it has been a plus for others who may not have been available to attend because of competing priorities, particularly those things that required them to remain at home. Online meetings also have allowed individuals with limited mobility the opportunity to participate from home. In the future, once we are able to meet in-person again, I would like to see a combination of in-person and online meetings. In-person meetings should be live streamed (with a way for virtual participants to ask questions and give comments) giving all citizens the ability to participate in ANC meetings.

- 4) **To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

I support the Mayor's initiative, in part. I do not think 12,000 units is enough affordable housing. I would like to see that number increase to at least 20,000. I think ANCs should play a pivotal role in addressing housing affordability by ensuring that residents are aware of projects that may impact their lives. For instance, in the area in which I live, East of River, we have the lion's share of affordable housing. I think affordable housing should be spread throughout the city and not concentrated in one area. That is

an issue that my neighbors are really concerned about. Further, I think the city as a whole needs to invest more in mixed income communities and not have one community shoulder the challenge of having one type of housing.

**5) Many retail and restaurant spaces are being threatened by COVID-19. What would you advocate to help support small and medium businesses in your community?**

Many small businesses in my neighborhood, like those throughout the city, have been impacted by COVID-19. Yet, our neighborhood continues to support the businesses to help ensure they survive. Unlike other areas in the city, our neighborhood does not have adequate resources in the way of small and medium businesses so we know the importance of keeping the ones we have by supporting them. Since we are in the process of revitalizing a major commercial strip, our neighborhood is working hard to keep our projects moving forward. The ANC must stay engaged to help the process by sharing information with neighbors and supporting the planning and implementation process via zoning and other permitting aspects of community development.

**6) What is the biggest issue in your neighborhood not already listed on this questionnaire, and what is your position on it?**

The biggest issue not included in this questionnaire is traffic. Our neighborhood includes Pennsylvania, Branch and Alabama Avenues SE, all major hubs into and out of the city. Traffic is at most times, unsafe. During rush hour, many commuters use our residential streets as ways to alleviate their wait in traffic on the major thoroughfares. This is dangerous for our community. Further, the speed of cars on the major streets is excessive and accidents are frequent. We need better traffic calming measures and enforcement. Additionally, we need a traffic study to determine how to deal with the massive amount of traffic that traverse our community daily.

**7) In fewer than 5 sentences, why do you think you are the best person to represent your SMD?**

I am the best candidate because I intend to work collaboratively with my neighbors for the betterment of our community. I will not work against my neighbors and pledge to be responsive to their calls. As a native Washingtonian, I understand the nuances of the District government and how to navigate it. I have no allegiances to one group or another and will work hard to be a voice for all of my neighbors.

**8) What are the greatest opportunities for growth, development, or change in the community, and how will you use your role to make it happen?**

In our largely residential neighborhood, a big segment of the population is aging. Many are passing on and their families are selling their houses. With that, we are seeing an increase in young families moving to the area. We are excited to welcome our new families and see growth in their choice to select our neighborhood. It also presents a challenge because our senior neighbors have been very active for years and have contributed greatly to the wonderful neighborhood we all enjoy. As new neighbors join the quest to improve life in our neighborhoods, there is sometimes a clash between the "old" and the "new." I intend to keep everyone engaged and reminded that we are all on the same team and want the same things: a safe, active, prosperous, and friendly community.

Yet, I am encouraged that needed services such as medical offices and an additional grocery store will be there for the surrounding communities I am also concerned about eventual traffic patterns with all of the additional services. We must invest in accessibility for community



members not just outsiders. The possibility of having a Circulator in that area is a great one. I will also work to ensure that the original plan for resident job opportunities is upheld. I believe the ANC must stay actively engaged with this project and speak for neighbors who may be negatively impacted.

Second, I think determining the pros and con and presenting the findings to the various stakeholders would be useful to the discussion. Naylor Gardens for example may not benefit from such change as it is already burden with parking challenges. However, certain hundred blocks on Alabama and Branch would and those residents would be impacted by such a change.

One of the organizations I provide board service for just received 50k grant from the Mayor to do just this. I also think the government needs to provide a stimulus package to help those business deal with the impact to their operations, life lease subsidies, stipends for workers and other operating cost.

I believe that ANC meetings have been great and a plus for public health, so that our residents can survive a Global Pandemic that disproportionately impacts the residents of 7B06. I understand and see that the online ANC meetings have been a minus for inclusion, accessibility, and transparency. ANC online meetings can leverage technology, to better advertise across platforms, and have them recorded to allow for captions.

Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? There is recent talk about \$6,000.00 grants for this family-owned businesses, but that is just a local solution to a National problem. **6) What is the biggest issue in your neighborhood not already listed on this questionnaire, and what is your position on it?**

The lack of a hospital for affordable and quality healthcare, specifically for Black Womyn giving birth within SMD - 7B06. For too long, this issue has been treated as a regular issue like putting a crosswalk in a residential neighborhood. It has been exposed due to the Global COVID-19 Pandemic, to be such a dismal healthcare infrastructure for Citizens in Ward 7 and 8, and that the need is urgent to be met. We want individuals to survive the Pandemic, but also want People in this community to give birth in a safe way, as they raise a family.

I am the best person to represent SMD - 7B06, because I have a believe that to improve life for those living in the community, we have to give them the power and the voice to shape their Future. I am a young progressive in the vein of Ward 4 Councilperson candidate, Janesse Lewis George, and have new ideas to tackle problems that have been plaguing our communities for decades. As commissioner, I would work directly with DDOT and other agencies to develop innovative ways to fund and develop multi-modal transportation options for residents EOTR. Investing in our future means investing in program/initiatives like VisionZero, which calls for an all hands on deck approach to solving for pedestrian safety.

As commissioner, I would specifically take the following steps to further inform and gain feedback from my neighbors to ensure buy-in by:

1. Creating and/or repurposing an existing meeting to share the VisionZero initiative with neighbors (discuss transportation options that best align to neighbor characteristics and demographics, etc.)
2. Gather their feedback on the overall plan and its impact to their daily lives
3. Encourage neighbors through advocacy and training to become better drivers by taking drivers training courses, and
4. Encourage neighbors to identify hazardous street conditions/intersections and report them ASAP

By establishing an open, transparent dialogue with my neighbors around benefits of the VisionZero Initiative, encouraging driver education training and assisting in the identification of personal ways each neighbor can create safe streets we will be able to increase pedestrian safety. It all starts with ensuring neighbors are up to speed and educated on how best they can participate.

3) **During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?**

The COVID-19 pandemic has change the way we move about in our everyday lives. This has also impacted the way our communities interact and conduct normal business and advocacy. I was very impressed to see how local ANCs reacted and pivoted to an all virtual platform. I believe the meetings have been open, transparent and overall efficient. I do believe that the all virtual shift has caused some neighbors to be left out of key discussions that impact their families and communities.

From my perspective, the biggest issue here is people who oppose losing parking spaces are most likely not biking, walking or riding the bus regularly, so the opportunity cost for this “abstract” idea of bike, pedestrian and bus service/safety is too high to justify taking parking spaces.

As a rule, I trust our community to look out for one another, and ultimately make the best decision when given all the facts. My approach would be to facilitate early engagement with the community to bring them the plan, make sure their concerns are addressed, and create an environment of open and clear communication so that concerns are addressed. In practice that would mean making clear to DDOT that I expected the most affected residents and the rest of my SMD and ANC 7C to be brought in during the planning stages of the project through presentations at community meetings, the Capitol View Civic Association and ANC 7C, and following up with DDOT to make sure any community concerns are addressed and updates/ amendments to the plan addressing those concerns are brought back the community for feedback and sign-off.

- 3) **During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?**

ANC meetings moving online is a mixed bag. As research around pandemic schooling has made glaring, income and lack of internet access are connected, creating a barrier to engagement on race and class lines. However, moving meetings online has also allowed those who are unable to attend meetings, including differently abled community members and parents, to be included.

Overall, I would like to see universal internet access, but in the interim, a combination of in-person meetings that can be joined virtually is the best of both worlds.

**Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

I support this initiative, though 36,000 additional housing units is not nearly enough to meet the need for the region, which will disproportionately fall on DC residents.

Also, given the extreme rent-burden faced by people who are under 30% AMI, this proposal doesn't go far enough in addressing the populations most vulnerable to displacement.

My SMD in Ward 7 is home to a public housing development which is currently being closed under the city's new communities plan, the 190-unit Richardson Dwellings, making my most important affordable housing role as a commissioner to make sure that residents are placed in surrounding properties as they should be.

As far as what my neighborhood can contribute, my SMD is already contributing far above what most communities in the city are, but making sure that the residents of the 190 unit public housing complex and the surrounding houses are able to stay in the area would be my top priority and most pressing issue. I would also work with the local neighborhood association help our seniors avoid predatory real estate flippers.

My community doesn't have any small businesses as of now, so for my community, the priority would be working to make sure that post-Covid we could bring businesses. **5) Many retail and restaurant spaces are being threatened by COVID-19. What would you advocate to help support small and medium businesses in your community?**

The Deanwood community specifically ANC SMD 7C04 has several entrepreneurs and business owners such as Pinky Eats and Milton Yates who have adjusted their business model as a result of the COVID19 pandemic. I will support small and medium businesses here in the Deanwood community by actively supporting and advertising events by business owners from ANC 7C04. In addition to supporting and advertising events by business owners I will support negotiating Community Benefits Agreements that will have positive financial impact for Deanwood business owners.

2) If there were a way to improve bus service or safety for people walking or bicycling in your neighborhood, but it required removing some on-street parking, how would you approach the situation? Give a specific example if possible.

Everyone deserves safe streets. There is a way to accomplish transportation improvements in a community that include the removal of on-street parking. It all starts with engaging affected residents from the beginning of the process, not after decisions are made. After nearly a decade in public service, I've learned that people truly want to be part of the process when it comes to community improvements. It is important that we value the experience of many who take public transportation, ride a bike or scooter, and walk throughout our community, especially people with disabilities. It requires us to be intentional in holding DDOT accountable on the lack of engagement with longtime residents and how improvements, like bike and bus lanes, benefits the community at-large.

As a Deanwood native, I've admired the beauty of the steep hills and large areas of green spaces since I was a child. Historically, our community has been ignored and starved for resources to improve our infrastructure for years. With so much growth in recent years, I've been challenged to fight for more traffic calming measures that meet the community's expectation while approving residential parking permit requests to limit the number of cars parking on various blocks. This year, after years of engagement with DDOT to bring forth initiatives that address traffic and climate sustainability in our community, I'm proud to support the Stormwater Management and Green Infrastructure Design project. This project will improve water quality, help reduce water quantity impacts to the Anacostia river from stormwater, and provide traffic calming benefits to reduce roadway hazards for pedestrians, cyclists, and motorists.

3) During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?

ANC meetings being moved online has created more access to our meetings for people who typically did not attend in-person before the COVID-19 pandemic. However, it has created more challenges for many people in our community that do not have access to the internet in their homes, issues understanding the technology to access the meetings, and a barrier for commissioners that feel they are limited in how they can engage the monthly sessions. We have a lot to learn from this experience but I'm confident we will have new voices in the new year that will be committed to finding ways of having meetings

with limited capacity in-person while expanding online access. This includes fighting for the internet to be a public utility that's initially free for underserved communities with a continued expansion city-wide.

- 4) To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

It's a shame how much of our tax money goes toward building luxury housing in this city. It's more a shame that so many community leaders from east of the river have been pushing for years for affordable housing to be fairly distributed across the city, not just in Wards 7 and 8. Mayor Bowser has finally heard that call and set an ambitious goal, but it will take more organizing to convince communities west of the river to support the shared burden of building more affordable housing. We must also be intentional in creating deeply affordable housing for families who may meet the income requirements but still don't make enough income to prevent housing insecurities.

During my service on ANC 7C since 2017, I have worked with my colleagues in supporting affordable housing projects that have prioritized building replacement units for public housing residents, like the Residences at Hayes and Providence Place, and strategically supporting the building of more affordable homes on vacant lots. I continue to fight to expand funding for the Housing Production Trust Fund and homebuyer assistance programs, and I unapologetically support strengthening and expanding rent control.

- 5) Many retail and restaurant spaces are being threatened by COVID-19. What would you advocate to help support small and medium businesses in your community?**

The inequalities across DC were already visible to all of us, but COVID-19 shined a bright light on what we could no longer ignore. Our city budget is a moral document and it must reflect the investments that are needed to support businesses during this pandemic, particularly small and minority-owned businesses that have historically been underinvested in for years. I have advocated for more grants to support small businesses and will push for DC Council to expand grant opportunities to formerly incarcerated residents that want to create their own instead of constantly being denied opportunities because of their past. We must also be intentional in holding DC government accountable in creating more retail opportunities on development projects the city underwrites.

- 6) What is the biggest issue in your neighborhood not already listed on this questionnaire, and what is your position on it?**

The biggest issue in our neighborhood is intra-community and police violence. We must ensure our communities are engineered with racial equity as the goal for disenfranchised residents. We must provide people living in Deanwood and across Ward 7 with valuable solutions to the issues of food deserts, lack of healthcare facilities, and concentrated crime. We must be intentional in tearing down barriers for those who are formerly incarcerated, including ending the use of past criminal history to determine eligibility for housing, education, loans, and other services and needs.

Critical conversations about the well-being of our neighbors coming home must be held with each other, especially since Deanwood has a resilient formerly incarcerated population that has been ignored for too long. Years of institutional racism have created an ugly and misleading narrative about those exiting the criminal justice system. Services must be aggressive and accessible to ensure citizens are given new opportunities to contribute to our communities in positive meaningful ways. Until we support people during the weeks and months after release with housing and employment opportunities, we'll never reduce recidivism, end mass incarceration, and attach the root causes of violence. As a core organizer with Black Lives Matter DC, this is my everyday work to defund our investment in racist institutions and refund our communities.

I have been a fierce advocate for the full implementation of the Neighborhood Engagement Achieves Results (NEAR) Act. The NEAR Act must be expanded to scale in all 8 wards and a vigorous and intensive public education campaign about the Act and violence intervention as alternatives to mass incarceration must start immediately. Additionally, several components of the NEAR Act are still not implemented as required. Therefore, I will:

- Fight to open the Office of Violence Prevention and Health Equity (OVPHE) as a stand-alone office;
- Push to move hospital-based intervention services from the Office of Victim Services and Justice Grants (OVSJG) to the Department of Health (DOH) as required in the Act;
- Expand investments in violence interruption programs and social services.

**7) In fewer than 5 sentences, why do you think you are the best person to represent your SMD?**

I believe I'm the best person to continue representing Deanwood in ANC 7C04 because I fully understand the history and the fighting spirit of our village. As a Deanwood native, I'm proud of my record of being a champion for working-class families that have been ignored and devalued as a voice for transformative change. I have fought for more funding for traffic safety on Sheriff Road, supported more affordable housing, collaborated on more support services for street-based sex workers, the first medical cannabis dispensary solely owned by a Black man and two more food options on the way, and the release of body-worn camera footage in the death of Jeffery Price by DC Police. This takes commitment to be defiant when it's unpopular and to be unapologetic when marginalized people are under attack. From sinkholes to the displacement of so many families, I will continue to be a fighter for Deanwood.

**8) What are the greatest opportunities for growth, development, or change in the community, and how will you use your role to make it happen?**

The greatest opportunity for growth, development, or change in Deanwood is through a number of vacant properties in the area and efforts to build community-wealth through community-owned development projects. I plan to double-down on the collective efforts to establish community land trusts and explore community-driven development opportunities through the recently incorporated Deanwood Community Development Organization. We still have long-standing infrastructure issues, especially in the Suburban Village section of the community, and I will fight to get the resources needed. I will also continue efforts to ensure every apartment community in Deanwood has a tenant association.

**9) Do you feel Ward 7 receives the same treatment as other Wards? If not, how can you use your role to bring greater equity to the community?**

It's been well known that Ward 7 does not receive the same treatment as other Wards. I hear this constantly from new Deanwood residents that move from other parts of the city. Our service requests take longer to complete, we constantly have to fight for any ounce of improvements to our infrastructure, and we lack resources to address the root causes of violence in our community. Unlike other community leaders in Ward 7, I have been intentional in using my position to bring more attention to issues affecting Deanwood. I may not have the salary and staff, but I do have the ability to organize and shake a few cages to get our return on our investments.

People in my neighborhood need cars to access basic amenities--groceries, healthy restaurants, doctors, pharmacies, etc. Unless and until DC brought these necessities to our area, I would not support removing on-street parking. In addition, restricting access to parking increases the amount of parking tickets issued, which leads to significant issues for people in Ward 7. More parking tickets lead to cars not being registered and drivers' licenses not being renewed, which leads to criminal charges. I do not support that at all.

I think this has been great for inclusion, accessibility, and transparency. With meetings online, people are able to access the meetings without having to leave their homes and families, and do not have to fight traffic, find childcare, or deal with any logistical challenges. However, as we know, some people operate better in person, and some people do not have adequate access to internet. While moving these meetings online has been helpful for many, we must remember that there have been some people left behind. Moving forward, all residents should receive meeting minutes, and have the option to choose to receive them in the mail or electronically.

The Mayors Maternal & Infant Health Summit this year was a prime example and experience of how digital platforms and access can enhance and complement an experience, and in the closing survey of the event, I recommended that digital resources and access complement the in-person event in the future.

- 4) **To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

I support an increase of affordable housing in Ward 7, in the form of workforce housing. My ANC should strongly advocate for housing to meet the needs of working persons who serve the community directly in their work and profession. 2) If there were a way to improve bus service or safety for people walking or bicycling in your neighborhood, but it required removing some on-street parking, how would you approach the situation? Give a specific example if possible.

I am in favor of improving safety conditions for pedestrians and cyclists in the neighborhood as long as the community is well informed of the process, and that current resident's concerns have been fully addressed. In light of my positive community engagement condition, my first step would be to consult my constituents and hold a community specific listening session, where I would work to elicit the feedback of those who would be most impacted by the proposed changes. In particular, I would want to take special note of any residents that may have disabilities, seniors, or any person that has a designated parking space on the street to understand how the proposed changes would affect their daily mobility. The purpose of the listening sessions would be to 1) understand the positive and negative impacts of the proposed expansion of bus service or safety for pedestrians and/or cyclists and associated on-street parking removal, 2) identify strong feelings in support or opposition, and 3) identify what, if any, previous interactions the community has had with the responsible agency (DDOT and Metro) concerning this proposed plan.

Once I understood the general sentiment of the impacted residents, I would initiate conversations with the relevant agencies to learn about their current plans and their past/current/future community engagement efforts, and relay my constituents' perspective. Next, I would organize a community meeting where I would invite the agency(ies) to speak and listen to the community members. Finally, I would work with my fellow ANC7E colleagues through the Transportation Committee to put forth a resolution in support or in opposition that weighs the community benefits, present recommendations, and clearly articulates the needs of my constituents.

3) During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?

I believe that it is essential to provide people with multiple ways to be involved in their ANC and community, particularly when unequal access to resources can effectively silence voices. In my community, the move to online meetings has been a plus for transparency; however, due to the vast differences in access to and familiarity with technology, it has been a minus for inclusion and accessibility. In my ANC, we have many households that do not have computers, internet-enabled devices, or general

internet access and thus were excluded from attending meetings. We have also seen a decline in attendance from some of our seniors that are not comfortable or familiar with the technology.

The digital divide is a long-standing barrier for my community. This is why I fought so hard and worked with the city to have the temporary library modular unit erected with computers and wifi services at JC Nalle while our Capitol View Library was closed for renovations. Many people in the community rely on the computers and internet services provided at our local library if they do not have access to these utilities in their homes. During the pandemic, due to library closures and limited hours, members of my community who relied on these resources were effectively excluded from access to ANC meetings.

Moving forward, when it becomes safe to meet in public again, I would like to see ANCs resume in-person meetings but continue to offer live broadcasting/streaming for those who cannot attend in person. I would also like to see a monthly newsletter sent to residents via mail that includes the meeting notes and a mechanism to allow them to provide comments to be amended to those notes at the beginning of the next meeting.

**4) To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

I support the Mayor's initiative to build additional affordable housing throughout the District; however, that housing must truly be affordable. I do not believe 60% of the area's median income is affordable! I have learned that when working with the government it is important to be specific and intentional in your requests and agreements. "60% or less" simply establishes an income maximum requirement; however, in its vagueness, it does not establish the income qualification floor and thus fails to provide sufficient information on what minimum income thresholds will be on forthcoming projects.

Based on Census data, 60% of AMI equals to around \$103,068.00 annually meaning that is the maximum a family can make and still qualify for affordable housing. A full-time worker making minimum wage makes \$31,200.00 annually. It's difficult for me to grasp how a DC resident that makes minimum wage can compete for housing against someone that makes more than triple their income unless we establish specific and intentional policies to make housing available to all DC residents.

I appreciate the question of how and where each neighborhood can contribute its "fair share" to addressing the housing crisis. East of the River, specifically Ward 7, cannot continue to be the only place to offer affordable housing opportunities, especially when we do not have the resources that people need to thrive. We only have three grocery stores, limited healthy food options, and less than adequate public transportation.

Nevertheless, in my single member district (SMD) and surrounding communities there are opportunities to build more housing that can accommodate and support residents at various income levels. I have long advocated for creating rental and homeownership opportunities mixed with retail, public, and commercial spaces at Fletcher-Johnson, George Washington Carver Apartment (47th/49th & East Capitol St SE) and at Capitol Gateway.

**5) Many retail and restaurant spaces are being threatened by COVID-19. What would you advocate to help support small and medium businesses in your community?**

Eliminate Delivery Discrimination! Before COVID, we had limited businesses that delivered to our neighborhood. I believe that restaurants and other businesses should offer their services to all persons regardless of the area code.

I would work with ANC7E's Economic Committee to advocate for policy change by DC Council to provide insurance bonding and tax relief to businesses. Insurance bonding would remove some of the costs borne by small and medium businesses and alleviate some of the risks associated with serving communities East of the River. Tax relief may be the determinant of whether

some businesses can remain open or must close, and thus I would work with my colleagues to ensure we advocate for responsible tax relief.

I would also organize my community to create opportunities to support local businesses. I would hold listening sessions with businesses in my ANC to learn how to best support owners and ways in which we can incentivize community members to frequent their establishments, such as providing community discounts. I would establish an ANC7E Business List for Community Contractors that would list local services such as landscapers, handy-persons, babysitters, and other service providers to distribute around the community to increase visibility and promote local services. Finally, I would encourage and help organize pop-ups in the community to create a safe space where people in the community can buy and sell their goods.

**6) What is the biggest issue in your neighborhood not already listed on this questionnaire, and what is your position on it?**

The biggest issue for my community is the Fletcher-Johnson site and its future development. Fletcher-Johnson first opened its doors to students in January 1977 and served more than 1,000 students annually until it was closed in 2008. The campus also included early childhood services, a health center and a community center. At 15.26 acres, Fletcher-Johnson is the fourth largest plot of District-owned developable land, but it is currently only zoned for residential use. While our neighborhood will most certainly benefit from gaining new residents, we need more amenities, including commercial and public spaces, to accommodate current and future residents.

Under my leadership, the Fletcher-Johnson Task Force partnered with ANC7E to add comments to the Comprehensive Plan aligned with increasing the density of residential units and allowing commercial development at Fletcher-Johnson. Moving forward, we will need to work with the Office of Planning to create a small area plan and petition the Board of Zoning Adjustment to designate that land for mixed-use development. Once it has been classified as mixed-use, as a community, we will be better equipped to work with the city and developers to create many homeownership, entrepreneurial, and employment opportunities for SMD 7E04, Ward 7, and the District residents. We will also be in a better position to negotiate a community benefits package that can support other initiatives to address grievances in the area.

**7) In fewer than 5 sentences, why do you think you are the best person to represent your SMD?**

I love my community. From getting lawns mowed, delivering food to seniors, relaunching the Marshall Heights Civic Association, and founding and leading the Fletcher-Johnson Task Force, over the last six years I have been a focused, consistent, and an effective agent of community improvement. I have built great relationships with the community, government, and the media that allows me to advocate on behalf of my community. I value collaboration and empowering the community and have the drive, determination, and initiative to translate those two forces into tangible projects and see them through completion. Finally, I have a clear vision for how I will improve my community during my term with a focus on Fletcher-Johnson's zoning, improving pedestrian and bicycle safety, connecting residents to services, and working with our elected/appointed officials to address the issues in my SMD.

**8) What are the greatest opportunities for growth, development, or change in the community, and how will you use your role to make it happen?**

I have had the privilege of watching ANC7E grow, and I will continue this trend as my community's representative. Our commission can benefit from having a person like myself as an able, active, and aware member. As a consensus builder who believes in strategizing and building teams, I will build robust community agendas to address issues and effectively leverage the Commission's great weight to address the needs of the community. I will continue to be responsive to the wants and needs of my community.

There are also two additional opportunities I would use my position to advocate for, which are: 1) creating opportunities for organizations to bring resources to the community, and 2) making the community safer to pedestrians and cyclists.

Resource Fairs. The BENCO shopping center is a prime location to work with the government, non-profits, and other sponsors to bring resources to this area in the community. I would use my role to bring the WOW bus, library card sign-up, hands-on CPR, STI/HIV testing, and other resources.

Crosswalks. The median on East Capitol has a semi-paved path to allow pedestrians to cross from the NE to SE side. However, there are no crosswalks on either corner of 46th Street SE. I would like to use my role to work with DDOT to install a crosswalk on that intersection.

Bike Lanes. I think it would be innovative to use the median on East Capitol and pave or carve out part of it for bike lanes. A lot of drivers are opposed to bike lanes on the street because they fear hitting bikers or they dislike tailgating them and having to slow down when they are in the lane. I imagine these lanes looking similar to the bike lanes on Pennsylvania Ave NW between the Wilson building and the old Newseum.

Traffic control. There is a lot of speeding in the community. Many neighbors want to erect speed bumps and traffic cameras as a means to control speed. I would like to work with those blocks that absolutely want them but also explore other innovative ways to decrease speeding on the blocks that want something different.

**9) Do you feel Ward 7 receives the same treatment as other Wards? If not, how can you use your role to bring greater equity to the community?**

No, Ward 7 does not receive equal or equitable treatment. I fundamentally believe that a commissioner's role is to represent the community and amplify their constituents' concerns. Aside from combatting the stigmas, stereotypes, and long list of "-isms" associated with living East of the River, I feel that Ward 7 can receive more equity by having its residents and commissioners increase their presence at the Wilson building and in government agency's offices. There's truth to the saying, "the squeaky wheel gets the oil." The stronger our voice and presence in meetings and hearings across the District, the harder it will become for Ward 7 to be an afterthought and the more attention people will pay to our needs.

As Commissioner, I will leverage my platform to mobilize my community by providing civic education on issues and elevating discussions in the community. I will also use my platform to demand the same level of respect and attention given to areas with strong voter turnouts by building coalitions, collaborating with other Commissioners, identifying partners best suited to address concerns, and testifying at performance and budget hearings hosted by DC Council or other relevant bodies. I will be present in my community, at the Wilson Building, and any other government agency to ensure that my community is present and its wants and needs are heard.

2) If there were a way to improve bus service or safety for people walking or bicycling in your neighborhood, but it required removing some on-street parking, how would you approach the situation? Give a specific example if possible.

Improving access to bus service and ensuring pedestrians are safe are two critical components of an efficient and safe transportation system. If the implementation of the aforementioned strategies required removing on-street parking, I would require that a robust assessment be conducted to determine the most appropriate locations based on factors such as current ridership, proximity to cycling trails, etc. This is incredibly important because not all streets may be the best streets to implement bike lanes and/or improve bus service. Further, residents must be engaged in the process of determine the feasibility of the implementation of these strategies.

3) During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?

COVID-19 has transformed the way that we communicate and do business. Moving ANC meetings online has improved accessibility for many residents and allowed participation from residents who may not have been able to participate in the meetings due to transportation and other barriers. Moving forward, I would like for ANC's to continue meeting online and gradually transition to a hybrid approach once it is safe to resume in-person meetings. I also think that ANC's should be required to improve their online presence since many constituents are now relying on information gleaned from social media and/or websites.

4) To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? I fully support Mayor Bowser's initiative to build 36,000 affordable housing units in the District by 2025. Currently Marshall Heights was identified as one of hottest neighborhoods in the DMV due to low housing cost and the availability of housing. Given

I think it's most important to hear the needs of the community and evaluate the street/ area in question. Listening to the community directly impacted is important to learn the street parking patterns. For example, we need to know if there are many cars parking on that street and when is the highest volume.

It is important to also learn from the community how many people are actually riding the bus or walking/ bicycling. There are cases where the community more heavily use their own vehicles than bus/ walking or bicycling.

As the community is rapidly changing, it is important to re-evaluate periodically how the community uses public and personal transportation and means of getting around.

3) During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?

While the pandemic has forced us to use alternative methods of communicating online, it presents issues for some community members. Some community members are older and do not have easy access to a computer (associated audio/ video) or may have difficulty navigating to the associated webpage.

Naturally, in person meetings provides a more rich experience of communicating for the meetings. If we are unable to meet in person, we should always make it simple for community members to dial in by phone.

We can even set up video display, (that also provides microphone audio and camera) of the meetings at safe spacious areas that can be open and operated according to CDC guidelines. Exploring hybrid methods to be sure everyone has easy access to inclusion in the meetings is important.

- 4) **To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

The median price of D.C. single family homes is growing at a significantly fast rate. Many families will be priced out of living in D.C., so it is important to support Mayor Bowser's affordable housing initiative. I support this initiative and believe that my role as an ANC will help guide development to be sensitive to areas near important resources like grocery stores, schools, and libraries. Strategically working with the community to address these needs will ensure equitable growth throughout D.C., so that everyone will have a chance to share and contribute to the joys of D.C.

Safety is one of the leading concerns in my community. In recent months there has been a number of crimes in the area. I would work with the community to increase police presence. I would share with the community the reimbursement support for using home safety technology such as camera door bells and alarms.

I would work on providing economic opportunities for the community as a more engaged community often has less crime. I would also make sure we are supporting youth activities and educational and career opportunities, to keep kids off the street from violence.

- 2) **If there were a way to improve bus service or safety for people walking or bicycling in your neighborhood, but it required removing some on-street parking, how would you approach the situation? Give a specific example if possible.**

If there was a way to improve bus service or safety for people walking or bicycling in the single member district of 7E07, but it required removing some on-street parking, I would ensure that we partner the Department of Transportation to understand that proposed strategy and the scope. During our ANC meetings and targeted communication to the community to discuss & understand the impact on residents and the proposed scope of the project.

We would work to select locations that would result in minimal disturbance to communities, while providing enhanced access and safety for residents. Additionally, this same thought process would extend to mass transportation needs to ensure greater access to and from the community. Ward 7 is full of hills and with that in mind, we must, also, give proper consideration to bicycle access and the ability to beautify and restore pathways that exist now.

### Bus Service

My exposure and use of the bus are limited, but as the Chairman of the Ward 7E07 Economic Development committee, I have found there's a clear opportunity to diversify public mediums to major corridors outside of Ward 7. Given that the vast majority of SMD 7E07 is residential space, it lacks immediate access to grocery stores or other locations outside of the Ward. Recently, I have begun engaging with the Transportation Working Group to find ways to revitalize plans for the addition of Trolley access to the SMD and, with hopes, of greater service to the Ward.

Through work with the Department of Transportation and WMATA, we'll assess the bus services provided and ways to enhance them and ensure timely services.

- 3) **During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?**

During the pandemic, ANC meetings have moved online, and I think the addition of this option has been positive. I routinely attend the ANC meetings and I present, as the Chairman of the Economic Development Committee for Ward 7E. I have noticed



more community involvement, in numbers and communication. As a result, the additional involvement has allowed for the expansion of the Economic Development Committee attendees. This new medium of communicating is allowing more to participate in these meetings and obtain the information needed. It goes without saying that these meetings have lasted until 10pm and occur during the work week. This new method of communication should be incorporated as part of the on-going meeting routine. And, the process should be enhanced to manager questions, online, for the community and to be archived and submitted to the respective Commissioner for review and response. Additionally, this would allow for recording of meetings for future auditing, accountability and community transparency. It would be ideal if all ANCs recorded their meetings. As a community member, I have reach though other ANCs meeting minutes and feel that more can be gleamed from recordings and/or transcripts of those recordings.

- 4) To meet the District's housing needs, Mayor Bowser has proposed building 36,000 additional housing units in the District by 2025, 12,000 of which would be affordable to people making 60% or less of the Area Median Income. Do you support this initiative, and if so, what role do you think your ANC could play in addressing housing affordability challenges? How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

I support this initiative, in part. I believe our Ward has a significant number of multifamily units and pre-existing residential properties. Those building can and should be enhanced, in overall condition. As a Commissioner, I would want to be involved in the specifics of the Mayor's plans. Specifically, regarding the "type of" housing that will be developed and the quantity expected to be developed in our area. The thought of a torrent of affordable units concentrated in one specific geo-area will have a long, and short term, affect on property values in that community. Additionally, African American Communities are historically undervalued and our grandmothers and fathers, mothers, uncles, and we [individually] have worked hard for these homes and the opportunity to enjoy value appreciation. With that, thoughtful consideration must be considered to the placement of units and less about the global initiative. As a Commissioner, I would want to ensure we have recurring updates on what the plan is, the long- and short-term economic impact on the community should be assessed. I would drive a discussion on the need for more commercial spaces in our Ward, within proximity to our SMD. In fact, the reality is that our SMD is more than 90% residential. As a realtor, I know that there is strong attraction to and value in this area, so I would strive to be a good steward and ensure oversight and communication of the plan.

- 5) Many retail and restaurant spaces are being threatened by COVID-19. What would you advocate to help support small and medium businesses in your community?**

The SMD of Ward 7E07 is limited in the number of businesses in our corridor. In fact, many of them are the only place where community members can access basic goods and services. As a result, there is not any report from the business community, in this area, of being threatened.

- 6) What is the biggest issue in your neighborhood not already listed on this questionnaire, and what is your position on it?**

The biggest issue in this immediate SMD 7E07 is economic development, of which has been addressed. In the perimeters of our SMD, there is an on-going uprise in street violence amongst rival communities. My position is that this is unacceptable, and more partnership must be had between DC Police and all of the Ward 7 Commissioners to sketch out a plan that will stabilize the community.

Work with the community to deliver our combined vision and hopes for growth and development to DC Councilmembers and DC City government. 2) If there were a way to improve bus service or safety for people walking or bicycling in your neighborhood, but it required removing some on-street parking, how would you approach the situation? Give a specific example if possible.

If improving bus service or safety for people walking or bicycling in my neighborhood I would first engage community members on such ideas. It's important to solicit feedback from community members when making decisions that will impact their quality of life especially parking. In engaging in conversation I would hear out community members on their concerns, fears and ideas. My proposal around improvement for bus services would include hours for parking being restricted On Minnesota Ave, and advocating to WMATA for adding express routes (including multiple Circulator routes serving East of the River) to prevent a log jam of buses on our busy business corridor. East Capitol Street offers a great place in ANC 7F to expand the opportunity for bike lanes. This would present a two-fold opportunity to make improvements for pedestrian safety and adding bike lanes. There are advocacy efforts underway to make East Capitol Street safer for pedestrians to include hawk signals, rumble strips and reducing the speed limit for vehicles. I believe these efforts combined with bike lanes would make for a winning combination. In addition to this I will continue to advocate for additional pedestrian safety features at the intersection of Minnesota Ave & Benning Road, adjusting the timing of the lights to ensure drivers aren't rushing to make a light that is timed badly or not wanting to sit in traffic because they missed the light, and also work with DDOT to ensure the return of TCOs at the intersection occurs post pandemic.

3) During the pandemic, ANC meetings have moved online. Do you think that has been a plus or minus for inclusion, accessibility, and transparency? What would you like to see ANCs do moving forward?

Since becoming chair of my Commission in 2018 I've worked to build our online presence through a website, mailchimp email list, twitter and facebook accounts. We also create a flyer each fall with the dates for the preceding year and distribute throughout the entire ANC, this year we voted to have the flyer mailed to reach as many residents as possible. I pushed for our online presence to be built while opting to continue using print literature to reach as many community members as possible not realizing that it would be a saving grace during the pandemic. While I would certainly say ANC meetings moving online has been a plus however there still is room for improvement. The pandemic has also shown us that post the pandemic we can use many of the functions setup during this time to continue including our community and provide accessibility to those who can't attend meetings in person. Our ANC will brainstorm ways to make this happen and ensure we utilize the resources at our disposal to make this happen. As it relates to transparency I would like to see each ANC be provided a DC Government website domain

(that is user and administrative friendly to update) as an online home for each Commission. Commission's being provided this online home would provide community members no matter where they live in the city a consistent place to always go find important information related to their ANC and serve as another way to hold their ANC accountable. I would like to see ANCs continue using online platforms to ensure accessibility of meetings and provide another way to include community members and be able to use their websites as a place to share playback from previous meetings.

How and where can your neighborhood contribute its fair share of the housing our growing city needs?**

I support the Mayor's initiative to build an additional 36,000 housing units in the District by 2025. I see my ANC playing a role in this with the redevelopment of East River Plaza & Senator Square. The owner/ developer is proposing to build 1350 units with 10% being a part of the city's inclusionary zoning program. I plan to advocate for an increase to the percentage of units to create an opportunity for my ANC to be a part of contributing to the Mayor's goal. Another location in ANC7F that could contribute to this goal is Reservation 13 (Hill East). I think it presents an opportunity to build housing that will create ownership opportunities. Our city's crisis related to the haves and have nots has been on full display during the pandemic. Way we break the cycle of poverty is ownership opportunities not building to solely allow developers to profit off people. We must truly be inclusive with prosperity and that means people over profit.

- 5) Many retail and restaurant spaces are being threatened by COVID-19. What would you advocate to help support small and medium businesses in your community?**

I would advocate the city to provide additional grant opportunities to ensure businesses in my community can survive should the pandemic last beyond this fall/winter. I'd also push for creative ways for businesses to safely welcome their customers back and ensure the city provides the means for this to happen. I'll also continue doing my part to pass out PPE in my community so that community members don't feel they can't visit establishments in the community because of their lack of a mask.

- 6) What is the biggest issue in your neighborhood not already listed on this questionnaire, and what is your position on it?**

The streetcar expansion from Oklahoma Ave to Benning Road Metro. My position on the streetcar expansion has shifted from 4 years ago in understanding the impact it will have on traffic and residents who own homes in ANCs 7F & 7D. While I understand expanding transportation options for residents we could achieve this by funding multiple Circulator routes in Ward 7 & 8 that achieves transportation equity while also rebuilding the Whitlock bridge and use remaining capital dollars to improve internet access in the neighborhood. Additionally when the streetcar expansion was proposed to go to Georgetown residents stood up and said no that didn't support it and the city obliged. I am appalled that our Councilmember has not heard the concern of residents in 7F01 on this matter as we've endured gridlock traffic for a number of years while the nightmare construction on Minnesota Ave seemingly lasted twice as long as it actually did to completion. We are tired of being unheard on this matter by DDOT, Council and the Mayor. We've also been told the street car expansion will bring additional economic opportunity to our community just as it did on H Street. That's unproven as of now as many businesses prior to the pandemic shutter in particular those owned by African Americans.

I do have a solution that in conversations many community members would be willing to support. Instead of the expansion going all the way to Benning Road Station stop the expansion at Minnesota & Benning with the stop ending in front of the Dorothy Height Benning Library. This solution is reasonable and would allow the city to accomplish its goal of expansion while at the same time ensuring resident of Ward 7 their voice matters on issues effecting them as tax paying citizens.

- 7) In fewer than 5 sentences, why do you think you are the best person to represent your SMD?**

I believe I am the best person to represent my SMD because I have a proven track record of fighting on behalf of my community. Since taking office I've worked to prioritize and advance my community and commission. From the impromptu walk through of our local Safeway with media to expose bad conditions to successfully stopping a Checkers from opening and going to the office of Douglas Jemal to oppose a Church's Chicken, the alleys and streets I worked with DDOT to have repaired and/or repaved; I've consistently been working on behalf of my community. I've worked with my colleagues to ensure our ANC's financial standing has become stronger with no missing or stolen funds and we've put over \$50,000 into community based events. Yet with the work that's been done there is more work left to be done; I want to foster already established relationships with community members and build new ones to work together with community members to build a community we can be proud to call home.

**8) Do you support the COREDC plan to locate a community-based residential facility (i.e., halfway house) at 3701 Benning Road NE?**

I do not support the largest federally funded (300 beds) halfway house coming into 7F01. In June we introduced a resolution at the ANC to form the Minnesota Ave improvement task force to submit budget and program recommendations to the Mayor and Council to improve the conditions of what Minnesota Ave presently looks like. The number of shootings that have occurred in 7F01 this year, the need for drug rehabilitation services, mental health support, housing and job opportunities make me worried that this location is not the environment for our returning citizen to be successful. My brother is a returning citizen and his father is currently finishing a 12 year sentence. My family has been impacted by mass incarceration like many families here in the District of Columbia.

To ensure our returning citizens are truly successful I support a collective plan for re-entry facilities in the District of Columbia. I plan to lead the charge to have Congresswoman Norton request the BOP to unilaterally change the contract so that multiple state of the art re-entry facilities can be built across DC. Ward 7 is prepared to receive returning citizens just not as the sole stand alone Ward in the city. This responsibility must be shared across the city just as the family shelters. We also call on the Mayor, Chairman, and Councilmembers to ensure this becomes a reality and isn't just a Ward 7 issue to carry.

**9) DMPED is likely to soon issue RFPs for portions of Reservation 13/RFK Site and will solicit ANC feedback. What aspects will you look for in the response to the RFP to support?**

As mentioned in a letter to DMPED, I would look for responses to the RFP that support job creation, inclusive economic development, all phases of Housing (affordable/workforce, market, and ownership), business development, and retail (specifically food options).
